## FEBRUARY ISSUE 2006

### MINUTES OF MEETING FEBRUARY 7, 2006

**Instinct Test for Lambs?**

**Herding Instinct:** There was a problem with our herding instinct tests held at the Nolan River Show in January 2006. AKC has refused to issue a Herding Instinct Certificate to 14 Exhibitors who qualified under Two different Judges if they were tested by both Judges at the same event. According to AKC, a person must pass under 2 different judges at 2 different events. The interesting thing is we had persons who passed on the same event under 2 different judges in 2005 and AKC issued certificates then. It was discussed whether to appeal AKC's decision vs paying extra fee to split out each day into 2 events. The problem with doing 2 events per day is that it would put us over our maximum number of events per year prior to our Fall 2006 trials. Carla Miller made motion that Wade Campbell handle appeal for only needing 1 HIC event per day. Lori seconded. Motion carried.

**Trial Trophies:** Mary Campbell gave report. Directors chairs are \$75 per chair. She will do herding whistle and lanyard for HIT and RHIT in April 2006 trial or anything which is interesting and reasonably priced. Andrea Bailey made motion that Mary handle the choice of trophies for the April trial. Lori Bowles seconded. Motion carried.
